BY THE NUMBERS

As Ellis County grows, so too does the work of this office. Through May of this year, there were 667 new felony cases and 1,030 new misdemeanor cases filed with our office, by more than 16 different law enforcement agencies. That projects to more than 4,000 new cases for 2017. With only 10 criminal prosecutors to handle that load, that's an average of more than 400 cases each.

Sheriff Edge's Vision: E-L-L-I-S

When asked about his vision for the sheriff of Ellis County, candidate Charles E. Edge replied: Ethics, Leadership, Loyalty, Integrity, and Service to the public; an acronym spelling ELLIS. A better answer could not have been pronounced. It was this answer as well as many others that earned Edge the title of Ellis County Sheriff. On April 25, 2017, Sheriff Chuck Edge, as he is commonly known, was sworn into office as the 40th Sheriff of Ellis County.

Sheriff Edge is most familiar to the citizens of Ellis County as the former Chief of the Waxahachie Police Department. He served as Chief of Police from 2007 to 2014. During his tenure, the Waxahachie Police Department was recognized by the Texas Police

Chiefs Foundation for its best practices and procedures. Prior to entering law enforcement, Sheriff Edge served in the United States Army from 1981 through 1986 as a Flight Engineer/Aircraft Maintenance Manager. Sheriff Edge logged more than 500 flight hours including 100 combat hours in Desert Shield/Storm on a UH-60 Blackhawk helicopter. Since leaving the Army, Sheriff Edge joined the ranks of law enforcement and has served in varied managerial capacities.

With Sheriff Edge's vision, the future looks bright for the Ellis County Sheriff's Office. Our office is looking forward to working with our new sheriff in his efforts to serve and protect the citizens of Ellis County. Welcome to the county!

The Rule of Law

BOUVIER'S LAW DICTIONARY defines the "Rule of Law" as:

"No one is above the law, and every act of government must be done through laws. The Rule of Law has many controversial aspects, but its core requires fair laws that apply to all persons in a state, that are enacted for the benefit of the citizens, and that are fairly and impartially applied without regard to the status of the persons to whom they are applied, by officials who are themselves bound by the laws

in every aspect of their duties."

John Bouvier, a French-born American jurist, wrote the *Law Dictionary Adapted to the Constitution and Laws of the United States of America and of the Several States of the American Union* in 1839. His words are as true today as they were in 1839. We are a country governed by the Rule of Law—not the rule of men. The core of the Rule of Law requires fair laws that are applied equally to all persons regardless of position,

stature in life, or birth rite. It entails fairness in the creation, application, and punishment for violations of all laws.

We recently celebrated our nation's 241st birthday, so this is a good time to reflect on some of the principles guiding our social experiment in self governance. We should recognize the men and women of all levels of government who guarantee the fairness and impartiality of the Rule of Law. We hope everyone had a Happy 4th of July!

Legal Update

State v. Rodriguez

A warrantless search of a college dorm room, at the request of the dorm’s resident director who discovered drugs in the room during a routine inspection, does constitute a violation of the Fourth Amendment. Students enjoy the same Fourth Amendment protection in their dorm rooms as any other citizen in a private home. Although dorm personnel have the authority to enter dorm rooms themselves to perform health and safety inspec-

tions, they do not have the authority to give police officers consent to enter dorm rooms.

US v. Wallace

Obtaining prospective cell site data does not constitute a search within the meaning of the Fourth Amendment. Like historical cell site information, there is no reasonable expectation of privacy in the prospective GPS data and location of a cell phone. Prospective cell site data falls outside the purview of the 4th Amendment.

Recently Disposed

Deborah Werkmeister found guilty and sentenced to 10 years TDC and a \$10,000.00 fine for theft of property less than \$100,000 but greater than \$200,000, enhanced by being a public servant.

Kevin Coffey found guilty of sexual assault of a child and indecency with a child by contact and sentenced to 20 years TDC on each to run consecutively.

Tyron Davis found guilty of 6 counts of failing to sign application for ballot, and 2 counts of false identification as a peace officer, and sentenced to 2 days in county jail and \$1,000 fine.

Daniel Hammons found guilty and sentenced to 75 years TDC each of two separate sexual assault of a child charges, to run consecutively.

Susie Lynch found guilty and sentenced to 730 days in a state jail facility for theft of property less than \$1,500, enhanced by two prior convictions.

Javier Martinez pleaded guilty to aggravated assault against a public servant and sentenced to 40 years TDC.

Aaron Perez found guilty to burglary of a habitation and sentenced to 7 years TDC.

Gerryke Young found guilty of organized retail theft and sentenced to 5 years TDC.

Jordan Caskey found guilty of burglary of a habitation and sentenced to 4 years TDC.

Jeremy Alvarez pleaded to failure to comply with sex offender registration requirements and sentenced to 25 years TDC.

Charles Johnson found guilty of theft of property less than \$2,500 enhanced by two prior convictions and sentenced to 15 years TDC.

Cedric Jones pleaded to sexual assault of a child and sexual performance by a child and sentenced to 20

years TDC on each charge to run consecutively.

James Goss found guilty of assault - family violence - impeding breath and sentenced to 45 years TDC.

Jaylona Hernandez pleaded to sexual assault of a child and sentenced to 8 years TDC.

Melissa Kappus pleaded guilty to DWI 3rd and sentenced to 4 years TDC.

Alvin Grover Nelson, Jr. found guilty of 11 counts of cruelty to animals and sentenced to 2 days in the county jail and a \$750 fine.

A person was found not guilty of indecent exposure.

Calvin Cole found guilty of unlawful possession of a firearm and sentenced to 25 years TDC.

Frank Ortiz plead to life sentences on the charges of murder and aggravated kidnapping respectively, and to 20 years TDC on an aggravated assault.
