
In accordance with Meeting Agenda Item 2.3, the Board discussed the new procedures for the Election of Certain Ellis County Bail Bond Board members pursuant to Section 1704.0535 of the Occupations Code as amended by House Bill 2894 which became effective September 1, 2015. Director Hinds distributed a draft of the notice to the Board members. The Board took no action on this item and it was tabled until the November 20, 2015 meeting.

In accordance with Meeting Agenda Item 2.4, Mr. Tom Benson spoke to the Board concerning his application process to use real estate as a security and set up a new bond company in Ellis county. Director Stamper moved that once the application is received, it should be set on the November agenda. Director Shinpaugh seconded and the motion was approved.

In accordance with Meeting Agenda Item 2.5, the Board discussed the importance of identifying correctly on the paperwork, the charge for which a person is being held in the Ellis County Jail. The Board took no action on this item and it was tabled until the November 20, 2015 meeting.


2. ADMINISTRATIVE
