- 3.4 Receive report from the Sheriff's Office concerning the outstanding bail bonds of Waxahachie Area Bail Bonds.

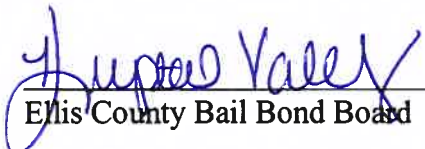
4. APPLICATIONS

5. EXECUTIVE SESSION

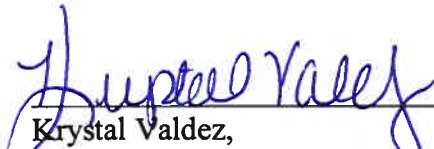
