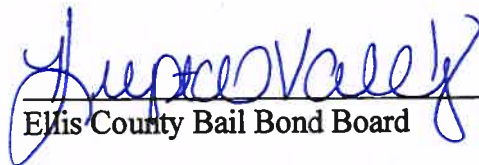

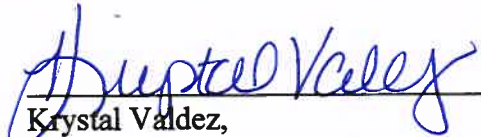
5. EXECUTIVE SESSION
