4. *APPLICATIONS*

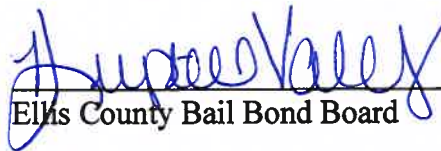

5. *EXECUTIVE SESSION*

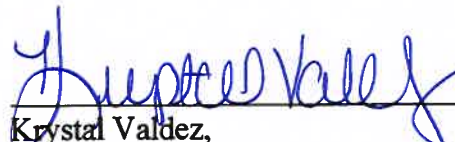
