**ORDER GRANTING OCCUPATIONAL DRIVER'S LICENSE
(REFUSAL)**

On this day came on to be considered the Verified Petition for an Occupational Driver's License of _____, Petitioner, Texas Driver's License Number _____, who resides at:

The Court finds that:

1. Petitioner's Texas driver's license was suspended.
2. There is an essential need for Petitioner to operate and drive a motor vehicle to perform an occupation or trade, for transportation to and from where Petitioner practices that occupation or trade, for transportation to and from educational facilities in which the Petitioner is enrolled, medical facilities and in the performance of essential household duties.
3. Petitioner should be allowed, authorized and granted the right to operate a motor vehicle pursuant to the driver's license ordered herein, for necessity shown, for a period not to exceed _____ (____) hours each day.
4. Petitioner has not had a prior suspension arising from an alcohol or drug related enforcement contact in the five years preceding arrest.

5. Petitioner has a valid policy of liability insurance as required by the Texas Motor Vehicle Safety-Responsibility Act and has provided the Court with proof of such insurance along with a certified copy of Petitioner's driving record. Petitioner shall maintain a valid policy of automobile insurance during the term of this occupational license.

6. The Texas Department of Public Safety should issue an occupational driver's license to Petitioner for the duration of the suspension period, accordingly.

It is, therefore, ORDERED by this Court, that Petitioner be and is here now granted an occupational driver's license and use of a motor vehicle on the following days, times, routes and areas, to-wit:

Days, Times and Counties Allowed/ Travel Log Requirement

Petitioner may operate a motor vehicle weekdays and weekends, up to _____ (____) hours each day, between the hours of 5:00 a.m. to 11:00 p.m., in Ellis, Dallas, Tarrant, Hill, Johnson, Navarro, Kaufman, Denton, Collin and _____

_____ Counties only. Petitioner shall maintain a detailed Daily Travel Log that is kept in his/her possession within any motor vehicle Petitioner operates, such Daily Travel Log to set forth the:

- Date of Travel
- Approved purpose for each travel
- Destination for each trip
- Time of Departure for each trip
- Time of Arrival for each trip
- Total Time Driven for that trip and the cumulative total for that day

It is further ORDERED that:

1. This order granting Petitioner's occupational driver's license is effective immediately.
2. Petitioner may use a copy of this Court order as an occupational Texas driver's license for 45 days after the date this order becomes effective.
3. The Texas Department of Public Safety shall issue to Petitioner an occupational Texas driver's license, referring on its face to this order of the Court.
4. The clerk of this Court shall furnish Petitioner with a certified copy of this order, at the Petitioner's request and expense.
5. The clerk of this Court shall forward a certified copy of this order to the Texas Department of Public Safety, together with Petitioner's petition, as required.
6. Petitioner must attend a program approved by the Court that is designed to provide counseling and rehabilitation services to persons for alcohol dependence within 45 days from the date of this order.
7. **This occupational driver license shall be automatically terminated and Petitioner is prohibited from operating a motor vehicle with this license if during the term of this occupational drivers license any of the following occur:**
 - i) **Petitioner is indicted for an alcohol or drug related driving offense; or**
 - ii) **Petitioner becomes subject to bond conditions that prohibit driving; or**
 - iii) **Petitioner is convicted of or obtains deferred adjudication for an alcohol or drug related driving offense.**
8. Petitioner may not operate a commercial motor vehicle.
9. Petitioner is allowed to take a driving test in the event it is necessary for the Texas Department of Public Safety to issue the occupational driver's license.
