**RESOLUTION OF ELLIS COUNTY REDISTRICTING COMMITTEE
RECOMMENDING REDRAWING COMMISSIONER PRECINCT
BOUNDARIES BASED ON 2020 CENSUS**

WHEREAS, an analysis of the 2020 decennial federal census disclosed that existing county commissioner precincts in Ellis County, Texas are unequal in population; and

WHEREAS, on October 5th, 2021, the Commissioners Court of Ellis County created the Ellis County Redistricting Committee to undertake the redrawing of the county commissioner precinct boundaries to equalize the population of the respective precincts in compliance with applicable requirements of state and federal law, traditional redistricting principles, and public input; and

WHEREAS, the Ellis County Redistricting Committee held (2) public meetings for the purpose of obtaining public input and maps outlining new commissioner court precinct boundaries; and

WHEREAS, the Ellis County Redistricting Committee received and considered oral testimony, presentations and various illustrative and proposed plans regarding the appropriate configuration of commissioner precinct boundaries to balance the population of the respective precincts; and

NOW THEREFORE BE IT RESOLVED, pursuant to the United States Constitution, the Texas Constitution, applicable Texas Statutes and the Voting Right Act of 1965, as amended, that the Ellis County Redistricting Committee recommends that effective January 1, 2022, Ellis County, Texas shall be divided into four (4) county commissioner precincts as depicted in Exhibit A to this Resolution, which contains (2) options for redistricting denoted as "Map A" and "Map B" of the respective county accurately depicting the boundaries and territories of the respective county commissioner precincts as redrawn, and which maps are incorporated by reference into and made a part of this Resolution.







Ellis County Commissioner Precinct 1 Plan A-1










