REQUEST FOR TIME SERVED

The court will consider alternative methods to discharge fines and court cost owed for a traffic or other class c misdemeanor conviction. The Judge must approve the request. The Defendant(s) must submit their request either through mail or in person. The Court cannot consider oral requests.

STEPS TO REQUESTING TIME SERVED

1. **PLEA OR FINDING OF GUILT/NO CONTEST-** The Defendant must have a plea or finding of guilt in the cause pending before the court.
2. **MAKE A REQUEST IN WRITING-** The Defendant must make a written request of the Court by submitting a Motion for Time Served.
3. **SUBMIT EVIDENCE OF INCARCERATION-**The Defendant should provide the Court with evidence of time served such as a book-in and book-out sheet.

IF TIME SERVED IS GRANTED

DRIVER'S LICENSE HOLDS- The Court will NOT automatically release a hold on a driver's License. It may be necessary to pay an Omni fee to release the hold.

IF TIME SERVED IS DENIED

ALTERNATIVES TO TIME SERVED- If the Defendant is not eligible for time served, the Court will consider alternatives such as community service. Request will need to be made in writing.
