Letter on the Adoption of the Fiscal Year 2026 Budget

Attn: Ellis County Citizens, Elected Officials, and Departments:

I am pleased to announce the formal adoption of the Fiscal Year 2026 Budget and its accompanying priorities. This budget provides a clear framework for Ellis County to meet the needs of a rapidly growing population while continuing to maintain one of the lowest property tax rates in Texas for counties of comparable size. Through careful planning and responsible allocation of resources, the adopted budget prioritizes personnel and capital projects that will serve our community well into the future.

With Ellis County's population now exceeding 240,000 residents, the demand for public safety services continues to increase. It is essential that the County maintain a competitive compensation structure for law enforcement personnel within the North Texas region. Following an extensive salary survey conducted prior to Fiscal Year 2025, the Commissioners Court acted to implement adjustments in that year's budget. The Fiscal Year 2026 adopted budget builds upon those efforts, aligning law enforcement salaries with regional benchmarks to ensure Ellis County remains a destination for the highest caliber of law enforcement professionals.

The Commissioners Court, in collaboration with the 2050 Strategic Plan Steering Committee, has also provided the vision necessary to address Ellis County's long-term facility needs. Over the past two fiscal years, we have opened Ellis County Central and the new Precinct 2 Subcourthouse. In Fiscal Year 2026, the adopted budget funds additional capital projects, including renovation of the Courts & Administration Building, construction of much-needed downtown parking, and the buildout of a new Elections and Records building. These investments not only strengthen the County's service capacity but also reduce the financial burden on taxpayers by replacing leased facilities with County-owned assets.

Ellis County stands at a pivotal moment in its history. Rapid population growth presents unique challenges, but through careful planning, strategic investment, and responsible fiscal management, we can ensure that growth strengthens both our economy and community character. The Fiscal Year 2026 Budget reflects that commitment and secures the resources needed to preserve Ellis County's standard of living.

I extend my sincere appreciation to the Commissioners Court, elected officials, department heads, and staff who contributed their insight and expertise throughout this process. Your collaboration has allowed us to adopt a responsible, forward-looking budget that will benefit the residents of Ellis County not only in Fiscal Year 2026, but for many years to come.

I welcome you to look through the Fiscal Year 2026 adopted budget, which demonstrates our shared commitment to meeting today's needs while preparing Ellis County for tomorrow's opportunities.
