## **Construction Permit INFORMATION SHEET**

No person shall perform or authorize Construction or Substantial Improvement within the unincorporated areas of Ellis County without first securing a permit.

In order to obtain a permit, the following items must be submitted:

1. A completed Construction Permit Application.
2. A set of plans that establish that the design and installation of the industrial oven. The oven and related piping shall comply with NFPA 86
3. Fixed fire systems are required for Class C or D ovens
4. Class A and B ovens that contain or are utilized for processing combustible material shall be equipped with automatic fire extinguishing systems
5. A permit fee in accordance with the Ellis County Fire Code.
