No person shall perform or authorize Construction or Substantial Improvement within the unincorporated areas of Ellis County without first securing a permit.

In order to obtain a permit, the following items must be submitted:

1. A completed Construction Permit Application.
2. Installation shall be in accordance with Sections 1204.2 through 1204.5 and the International Building Code or International Residential Code
3. The electrical portion of solar PV systems shall be installed in accordance with NFPA 70
4. A permit fee in accordance with the Ellis County Fire Code.
